## Case study 12:

As a part of the national measles elimination campaign the Ministry of Health, Harmonia decided to conduct a mass immunization campaign for all children 9 months up to 15 years of age on <u>1 March</u> <u>2016</u>. Parents and guardians of eligible children were asked to bring them to the nearest health centre for MR vaccination.

The star children's orphanage was located at # 23 Aries Street, Province Yellow Location 9. It was very close to the Platinum Primary health Unit. The phone number of the orphanage was +12 345 67 98 654. The orphanage warden Mrs Brown decided to take the 8 children in the afternoon to the Primary Health Unit Platinum in the afternoon for the immunization.

Ms Brown took the children to Primary Health Unit Platinum, located at # 2 Aries Street, Province Yellow for the MR vaccine. The vaccine was administered by Ms Sadhna a new vaccinator between 3.15 and 4.15 pm. The details of the vaccine and the diluent are given below

One of the children from the orphanage who was vaccinated was a boy named Surendran with date of birth 11.11.2011.

The same day evening, Surendran developed high fever and complained of pain at the site of injection. His vaccinated arm started swelling. He refused to have food and started vomiting severely, he had generalised seizure at 10.30 pm, he was rushed to the Platinum Central Hospital at 11.00 pm. There he was examined by Dr Celine, the paediatrician of Platinum Central Hospital (e-mail id: <a href="mailto:celine@Platinummail.com">celine@Platinummail.com</a>; Phone +12 345 67 98 765) who made a diagnosis of toxic shock syndrome and admitted him to the ICU.

At 11.45 pm of <u>1 March 2016</u>, Dr Celine telephonically informed the District Immunization Officer Dr Michael Jackson who works at office of the MoH, Seaview Road, Platinum district, Province Yellow, Harmonia (email: <u>michaeljackson@123mail.com</u> Phone +12 543 21 67 895) about the admission of Surendran. Dr Michael Jackson promised to visit the hospital as soon as possible and told Dr Celine to assign the case number HAR-PRV4-PEPP-2016-0022 in the AEFI reporting form and initiate the AEFI reporting process. Dr Celine collected the details and completed the AEFI reporting form on <u>2 March 2016</u> at 12.30 AM. Surendran was still in the ICU and had not recovered at the time of completing the form.

Dr Michael Jackson further checked the details of the vaccination session with Ms Sadhna the new vaccinator and discovered that she had reconstituted all vials of the MR vaccine on the evening of 29 February 2016.
